PET CARE

1. ____ I authorize Agape Pet Sitting to perform pet care services as outlined in Client Profile and Scheduling Form which shall become part of this contract.
2. ____ I have completed the Vet Authorization Form provided by Agape Pet Sitting Services.
3. ____ Agape Pet Sitting accepts no responsibility for security of the premises or loss if other individuals have access to the home during the term of this agreement. Pet care will be performed only by Agape Pet Sitting during all assignments.
4. ____ I agree to reimburse Agape Pet Sitting for any additional fees for providing emergency care, as well as any expenses incurred for unexpected visits, transportation, housing, food, or supplies.
5. ____ Agape Pet Sitting agrees to provide the services stated in this agreement in a reliable, caring and trustworthy manner. In consideration of these services and as an express condition thereof, the client expressly waives and relinquishes any and all claims against Agape Pet Sitting, its employees or assigns, except those arising from proven negligence of the pet sitter.

6. _____ Agape Pet Sitting will not be liable for the injury, disappearance, death, or fines of any pet with unsupervised access to the outdoors.

7. _____ Client will be responsible for all medical expenses and damages resulting from an injury to the pet sitter or other persons by the pet. Customer agrees to indemnify and hold harmless Agape Pet Sitting in the event of a claim by any person injured by the pet.

8. _____ Agape Pet Sitting reserves the right to terminate this contract at any time, at its sole discretion; likewise, Client may terminate this contract at any time. There is no term of contract for daily service.

9. _____ It is expressly understood that Agape Pet Sitting shall not be held responsible for any damage to client's property, or that of others, caused by client's pets during the period in which they are in its care.

10. _____ Fees are earned upon acceptance of pet sitting reservations. A deposit of half the amount of the services booked is due at the time of reservation. Final payment is due in full within a week of service. A fee of \$30 will apply to all returned checks. Payments can be made via PayPal, Venmo, check, or cash.

11. _____ I attest to the fact that all licenses and vaccinations required by the State _____, the City in which I reside and/or the County of _____ are current according to the law.

12. _____ I authorize this contract to be valid approval for future services so as to permit Agape Pet Sitting to accept my reservations via website request and confirmation email, and enter my premises without additional signed contracts or written authorization.
